JOINT ACTION KICK OFF POSTPONED


After thorough review and careful consideration, the Joint Action coordinator has decided to postpone the formal start of the Joint Action to a later date. As a consequence, the planned Joint Action Kick Off Event had to be postponed as well. A legal issue blocking the preparatory work of the Joint Action lays at the basis of this decision. A new date for the Kick Off event will be communicated as soon as possible.

NEW VERSION OF THE PLAN AND BUDGET

Thanks to all partners' hard work and commitment, a new version of the Joint Action Plan and Budget has been prepared and has been sent by Work Package 1 to the European Agency for Health and Consumers and to the European Commission on November 30th. Work Package 1 is currently awaiting comments on this new version.
