

- To provide advice on specific dissemination and sustainability questions
- To engage in action-orientated discussions on how to disseminate and implement JA products, and which tools, strategies and partnerships would be needed





The aim of the participation in the stakeholder forum is (2)


- To create a shared vision by indicating how health workforce planning efforts can help to realize the sustainability of health workforce in the various EU member states and at the European level.

- To help develop an action plan (together with of a group of experts) to implement health workforce planning tools in the daily practice of healthcare administrations and EU-policy







#### WHY IS STAKEHOLDER ANALYSIS IMPORTANT?

- to identify all key stakeholders
- to list and assess the stakeolders in terms of their interests in the project
- to yield useful and accurate information on health workforce stakeholders
- to support the activities of core work packages
- to find the effective dissemination channels for all stakeholders
- to involve the stakeholders in joint action activities
- to get to know the stakeholders needs
- to involve stakeholders to actively promote JA outputs at national and European level
- to create two way flow of information









#### **HOW TO ACHIEVE THESE GOALS?**

- conduct a stakeholder analysis that reflects the reality
- communicate and agree on pending list of relevant stakeholders
- define the needs of stakeholders groups and adapt the dissemination channels accrodingly
- communicate closely and continuously with Knowledge Brokers as the initial intermediators between JA and stakeholders
- to get to know the stakeholders needs and opinions



### 4 STEPS IN ACHIEVING QUALITY SKD ANALYSIS OUTPUT

- IDENTIFYING THE STAKEHOLDERS ACCORDING TO THEIR SCOPE TO THE JA
- IDENTIFYING THE DEEPER LINKAGE BETWEEN THE JOINT ACTION AND APPOINTED STAKEHOLDERS
- IDENTIFICATION OF MOTIVATION OF THE SPECIFIC STAKEHOLDERS
- RIGHT USAGE OF DISSEMINATION CHANNELS

The SKD analysis gave us the primary target groups of the JA. According to the results we have devided the stakeholders into 3 major groups as shown in the results.





#### Structure of national stakeholders

- Political level
  - Ministries of Health
  - Ministries of Finance
  - Ministries of Education
  - Public Health Bodies
  - Regulatory bodies

- Strategic level
  - Statistical offices
  - Health information centres
  - Health insurance companies
  - Quality institutes

- Implementation level
  - Health chambers and associations
  - Health professional organizations
  - Medical schools and universities
  - Hospitals

## A co-productive relation between professional knowledge brokers and the Joint Action (2)


As a Professional Knowledge Broker:
