## REMINDER

### The role of WP7

- Creating and sustaining a network of experts within EU,
- Together with the participants in WP4, 5 and 6, and the identified experts, WP7 will propose working modalities of a network capable of supporting any roll-out projects across the EU.
- **By the end of 2014**, WP7 will examine the added value for a new proposal to continue the European network on health workforce planning with the aim to implement the roll-out plans with the support of the technical and scientific expert groups in all EU members. WP7 will develop a business plan, including a cost/benefit analysis for this proposal, and a request or co-funding under the Health Programme 2014-2020.

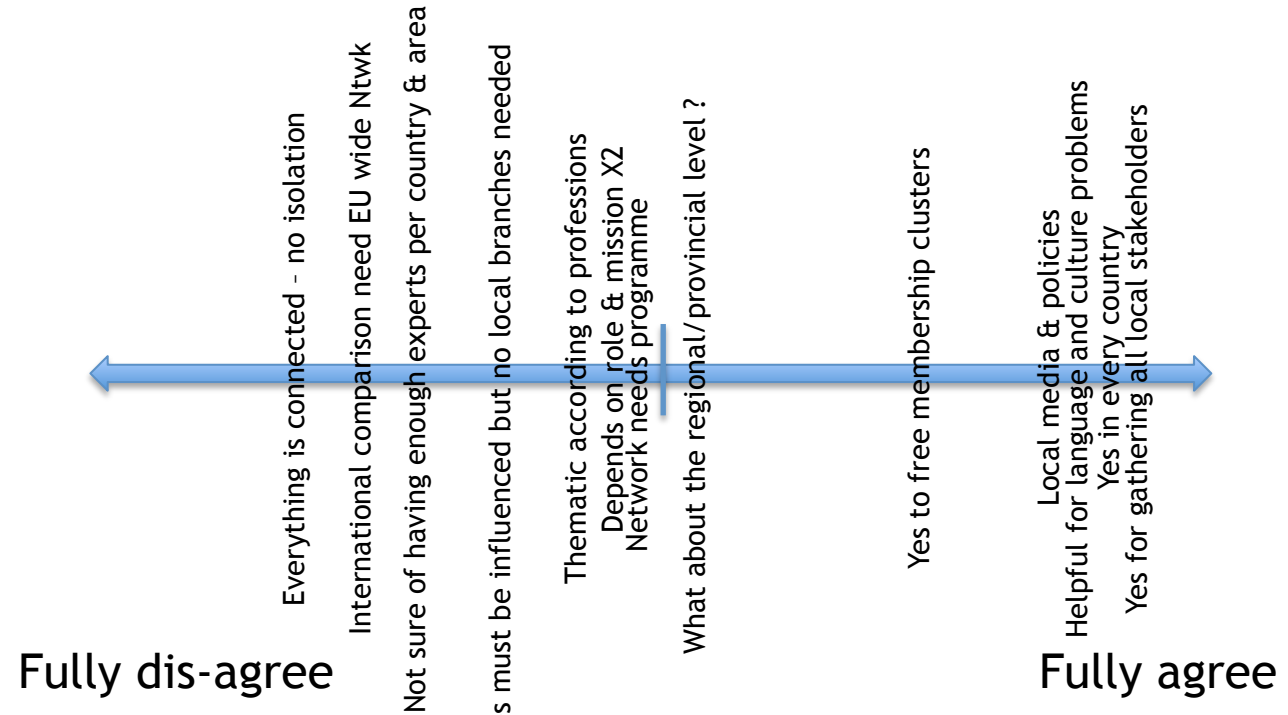
Topics	Most striking idea
Meet & train	<b>Globally favourable, but not necessary physically and concerns about the cost / <i>twice per year</i></b>
Local branches	<b>Majority favourable / <i>free to join and not necessary everywhere</i></b>
Share info.	<b>Definitely Yes / <i>defining the goals of the network is vital</i></b>
Publication	<b>Major way to disseminate in current context, but it is not the main task / <i>Many positive against some resistance</i></b>
Consulted on policies	<b>We should propose, inform and follow up / <i>how to motivate it – what about the feasibility</i></b>
Portal	<b>Very important as next step of the project / <i>close forum, open forum – various options</i></b>
Virtual observatory	<b>No / <i>hard to define, important for comparison analysis but variety of systems</i></b>
JA netw. Vs EU existing networks	<b>Not merging, but affiliate / <i>learning from each other, funding?</i></b>

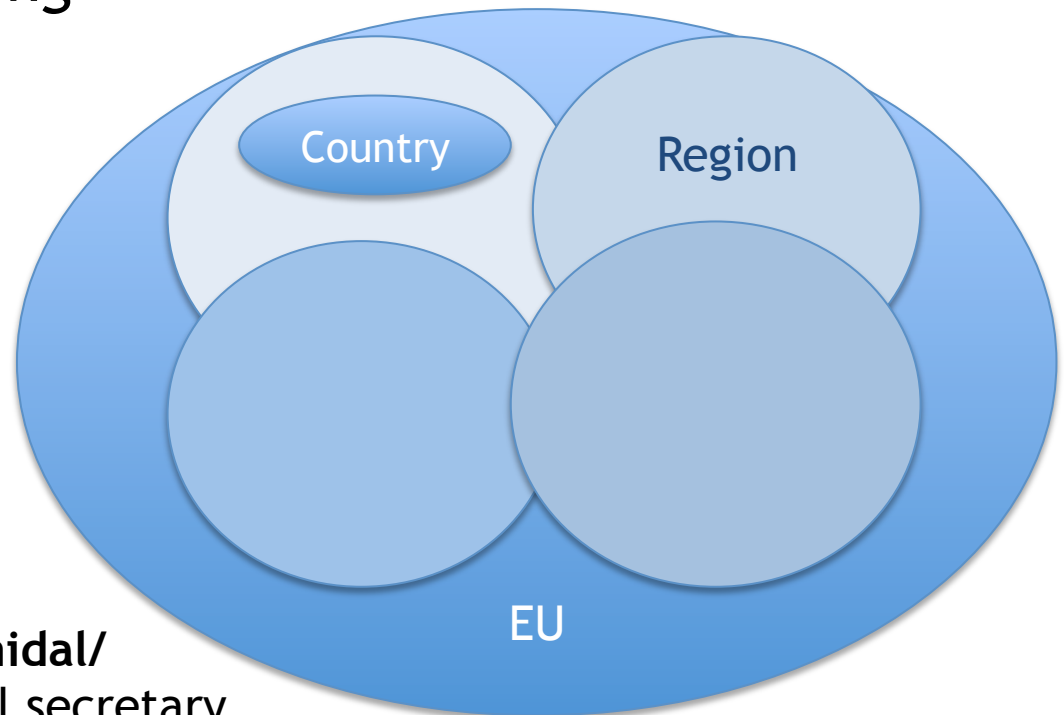

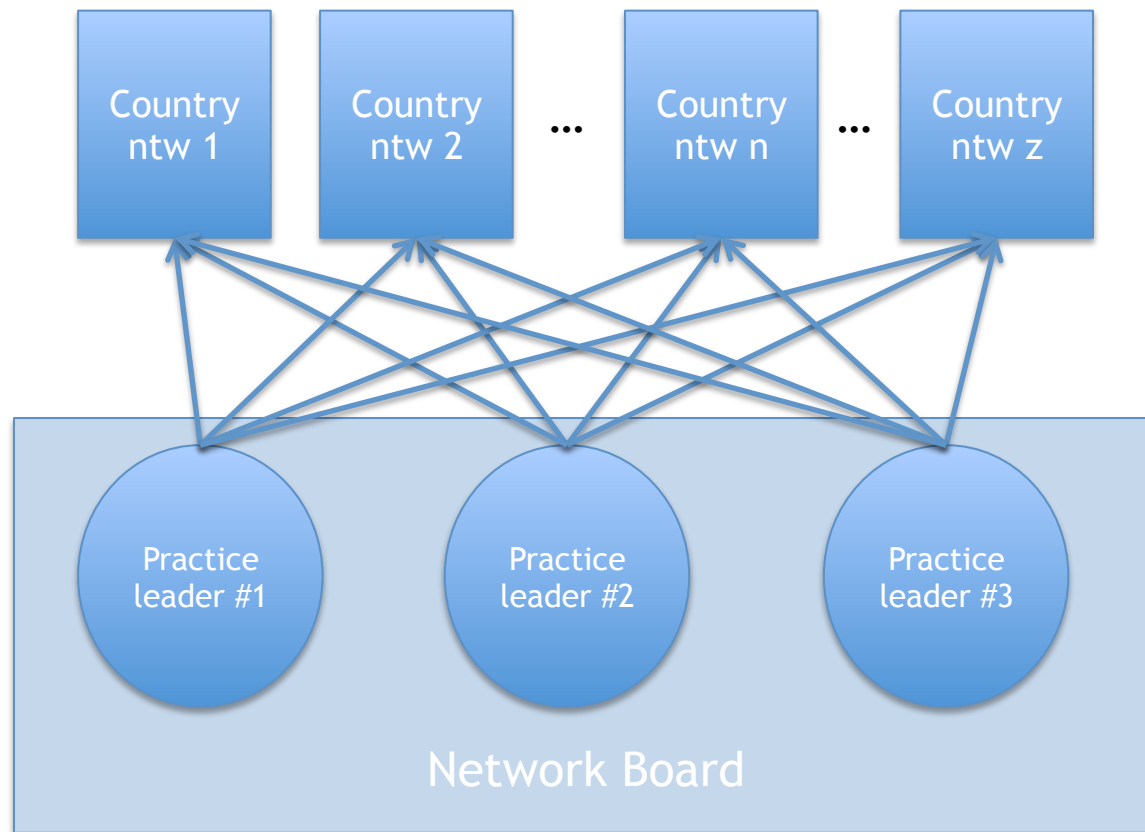

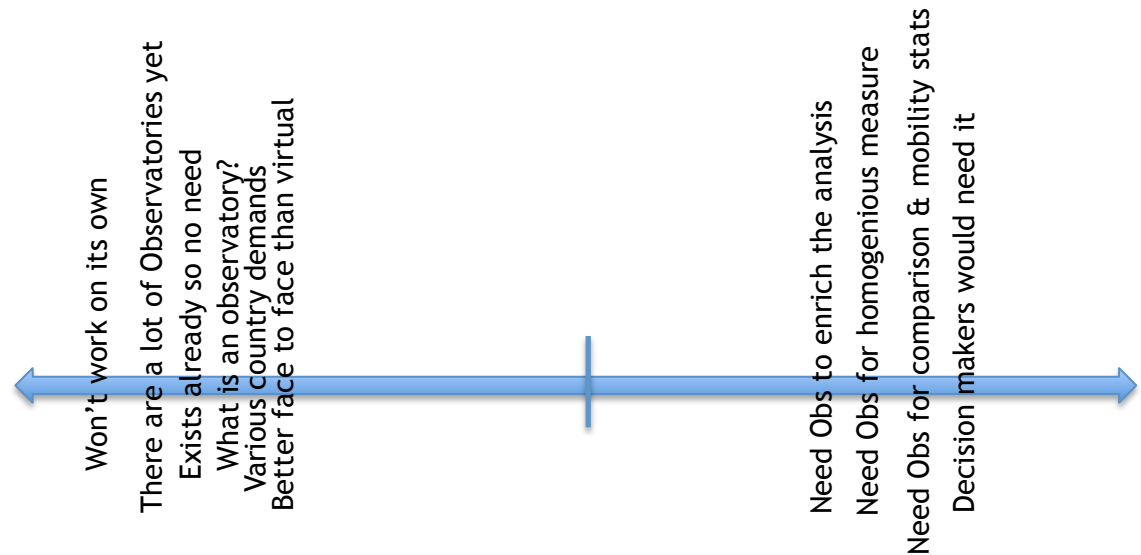

1. Definition Observatory & list of task with input from matrix

2. Discuss the Alternatives

- International bodies (OECD, IOM, EUROSTAT ...)
- Specific bodies like
  - **European Observatory of Medical Demography**
    - to carry out a state of play (numbers, density, distribution, modes of exercise and medical and surgical specialties)
    - to tend to a harmonization of the databases between the Member States
    - to carry out an analysis of the migratory movements between the Member States
  - **Or HPCB for migration**
    - HPCB works to ensure that health professionals can effectively take up their rights of free movement while enabling regulators to establish that these healthcare professionals are fit and safe to practise.
- Network of National Planning units
- Network of competent authorities (ENMCA/EurHeCa)
- Network of Health Observatories / Public Health Institutes
- ... others

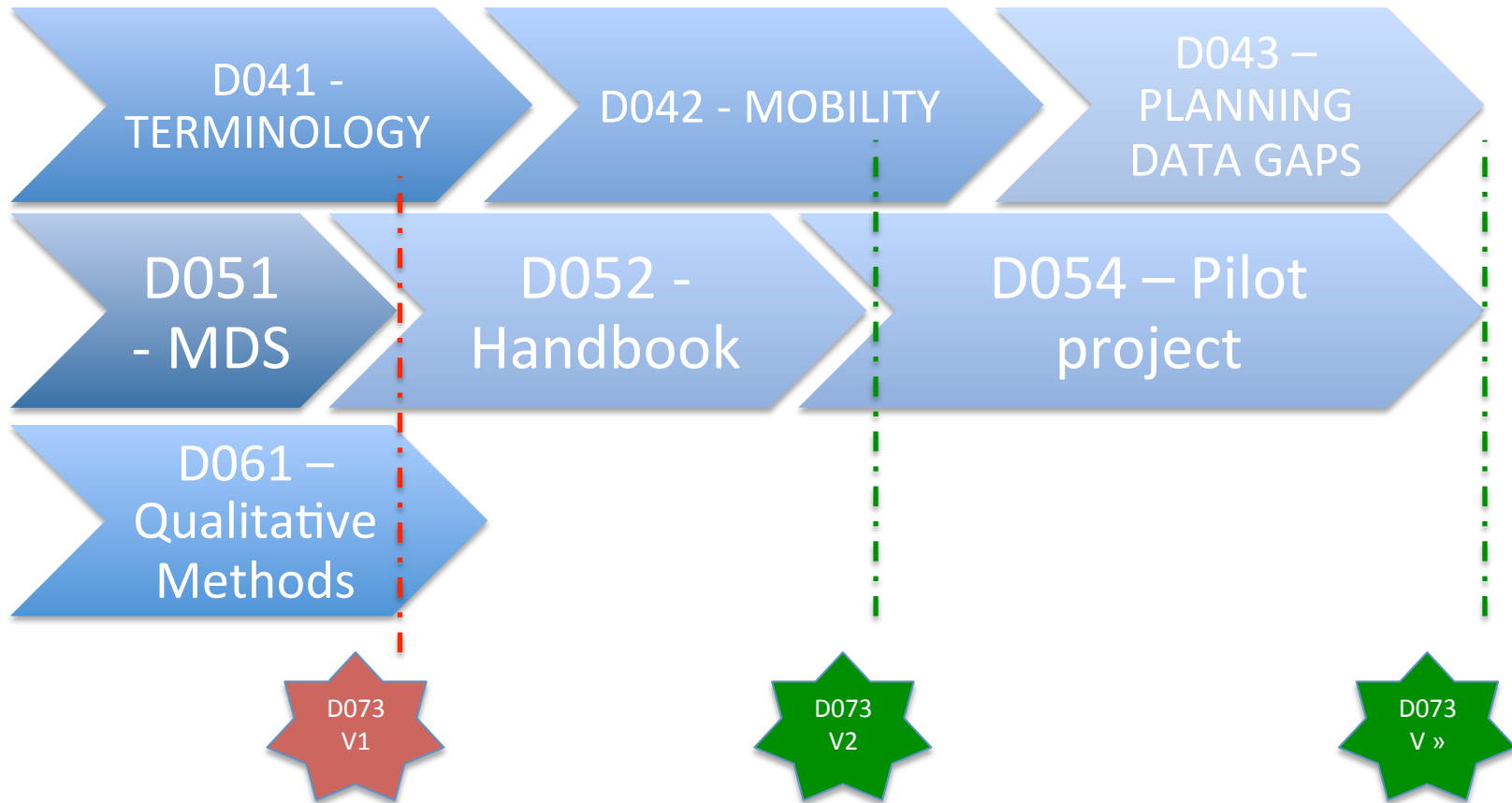
### Mapping the technical outcomes of JA

## Group 1 / from LONDON

The question was: How to propose best practices on legal instruments for data collection?

### First inventory of recommendations:

1. To propose a Set of Best Practices and to give opportunity and space to have a choice to use the Best Practices according the needs (relation with D052)
2. Strong support from EU regarding the importance on Long Term Thinking (because of dynamic changes; awareness rising)
3. To propose to have 1 Central Registration Authority *per* MSs
4. To propose Agreement Framework (not legal framework)
5. To highlight the Issue about Information exchange (Collective EU and global goals regarding HWF shortage)
6. To improve existing mechanisms for planning / information exchange and to add new proposals
7. To propose the integration of data / to agree on goals
8. Emphasize on the rapid change of data (no static but continuous and flexible data collection)
9. Emphasizing on sharing - to be addressed to EU
10. Plan the Human Resources with regard to financial issue

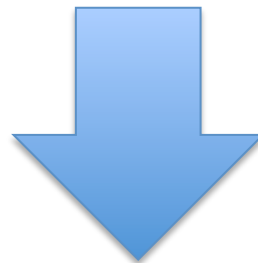
