

- Stakeholders involvement is one of the critical aspects of the entire planning system






THE IMPORTANCE OF STAKEHOLDERS IN THE PLANNING PROCESS

- Stakeholders' involvement plays an essential part in order to develop a integrated, comprehensive national health workforce policy
- ➤ The Handbook on Planning Methodologies clearly indicates that all of the planning models presented in the Handbook include the stakeholders (mostly as the advisors)



- Stakeholders may differ between member states but generally this will include the training institutes, the professionals, the health insurance companies and general public
- Participation of the stakeholders in the process of setting the goals is advisable
- Regular communication on the topics under revision and on monitoring results of the progress made is essential to keep stakeholders involvement guaranteed
- The planning instruments have to be at the disposal of all stakeholders in order to create a level playing field







Stakeholders' involvement in the Handbook

- Each of the Health workforce planning system described in the Handbook pays great attention to involve various stakeholders in both the construction and feeding of the forecasting model
- The roles and responsibilities of all stakeholders should be defined in order to manage the effective stkeholders' participation
- Stakeholder analysis represents the tool to identify all stakeholders and guarantee wide and cross-sectional participation






Stakeholders' involvement in the Handbook 2
